# **Submission Rules**

\* Please note that the papers published in "CiDER-PDP" have not been reviewed or peer-reviewed by experts.

### [Purpose]

The CiDER Policy Discussion Paper (CiDER-PDP) is a compilation of research results by CiDER faculty and related parties in a paper format based on CiDER's Vision/Mission. The purpose of this publication is to contribute to the discussion of policy recommendations and policy evaluation in a timely manner.

#### [Submission Eligibility]

Authors must meet the following criteria at the time of submission. If there is more than one author, the list must include those who meet the submission qualifications.

#### 1.CiDER Members

(CiDER full-time Academic Staff and Researcher, Concurrent Academic Staff, Visiting Academic Staff and Researcher, and Collaborative Researcher)

- 2. JSPS Postdoctoral Fellow (for which a CiDER member is the host faculty member)
- 3. Master's and Doctoral Students supervised by CiDER members

(If only students are authors, they must obtain permission from their faculty advisor, a member of CiDER, to submit the manuscript, which must be notified at the time of submission.)

4. Those deemed eligible by the CiDER-DP/PDP Steering Committee

#### [Note on Submission]

- 1. As a rule, papers for submission must be written in Japanese or English.
- 2. Submitted papers will be assigned a serial number and posted on the CiDER website archive.
- 3. Withdrawal of a paper is not permitted in principle. On the other hand, if you wish to update the information described in the article, you may do so after clarifying the archive. In such cases, please send the updated file to the contact below with an apparent reason for the update.
- 4. As a rule, submissions of papers already published in journals, books, etc., will not be accepted.
- 5. The CiDER-DP/PDP Steering Committee may withdraw a paper from publication or suspend its publication if it deems it necessary from the viewpoint of ethical considerations, etc.

#### [Submission Procedure]

Download the prescribed cover page format, fill in the required information, and send

it with your paper (PDF file; in principle, no more than 20 MB) to the administrative office <dp\_pdp@cider.osaka-u.ac.jp>.

The paper should clearly indicate the title / abstract / names and affiliations of all authors / responsible author(s) (if any) / keywords / citation information (references) / ethical considerations (status of appendices to the ethics review committee, etc.) / conflict of interest relationships / authors' contributions (contributions, roles, etc.).

Up to five Excel files or other related data may be attached.
